

CONSENT TO ELECTRONIC RECEIPT AND/OR EXECUTION OF CERTAIN CONTRACTS AND RELATED NOTICES AND DISCLOSURES

You are submitting certain information to a solar installation company (“installer”) in exchange for a referral fee as per the Referral Program, which program is administered by Sunlight Financial LLC (“Sunlight,” and collectively, the "we," "us," and "our"). We may need to provide you with certain communications, notices, agreements, statements or disclosures in writing (“Communications”) in connection with any of our products and/or services. Your agreement to this Consent to Electronic Receipt and/or Execution of Certain Contracts and Related Notices and Disclosures (“ESIGN Consent”) constitutes your consent to receive Communications electronically from us and to the use of electronic signatures in our relationship with you. If you do not consent to this ESIGN Consent, you should not submit your information to us. The words "you" and "your" mean the person executing the ESIGN Consent and receiving these disclosures.

To receive Communications electronically, you will need:

- A functioning personal computer, tablet or other electronic device (a "Device");
- A connection to the Internet and an e-mail account;
- An Internet browser that we support that has JavaScript and cookies enabled, including Internet Explorer 10 or higher;
- A current version of a software program that accurately reads and displays PDF files;
- Operating system software that will support the foregoing;
- Access to the email address provided to us; and
- If you use a spam filter that blocks or re-routes emails from senders not listed in your email address book, you must add no_reply@sunlightfinancial.com and referrals@sunlightfinancial.com to your email address book.

In order to retain and/or print Communications sent to you electronically, your device will need to be able to save and store Communications and/or you will need a functioning printer connected to your device.

These minimum requirements are subject to change. If these requirements change in a manner that creates a material risk that you will not be able to access or retain documents by email, you will be sent a statement with the new revised hardware and software requirements for access to and retention of the Communications and you will have the right to withdraw your consent without the imposition of any fees and without

You may withdraw your consent to receiving Communications electronically at no charge and you have the right to receive Communications in paper form by contacting us at support@sunlightfinancial.com, (888) 850-3359, or Sunlight Financial LLC, 101 N. Tryon Street, Suite 1000, Charlotte, NC 28246. Please note that you may still receive Communications from us electronically until we have processed any withdrawal of consent.
